Applications are invited in a prescribed format from the candidates belonging to Rairangpur Sub-Division for admission into a non-residential free coaching programme for Competitive Exams for first batch starting from March, 2025 spanning 3 months by ASPIRE-GCSA at RAIRANGPUR. All eligible and interested candidates may apply in offline mode only. Interested eligible candidates seeking admission into this course have to download the application form and instructions from the website <u>https://mayurbhanj.odisha.gov.in</u> and submit the filled in application form by Hand at respective Block Offices with requisite documents on or before 20th February, 2025.

ELIGIBILITY CRITERIA:

1. A candidate must be a resident of Bamanghaty Sub-Division (Blocks-Kusumi, Jamda, Rairangpur, Tiring, Bahalda, Bisoi, Bijatala, Rairangpur municipality)

2. Qualifications: A candidate must hold a Bachelors Degree from any subject from any recognised University. However, students who are appearing /appeared or result awaited for their final UG exams can also apply, with the condition that they would be required to produce a declaration from the concerned College/University

3. Age Limit: Minimum 21 years and maximum 27 years. In case of belonging SC/ST candidates, the age limit will be up to 30 years as on 01.01.2025.

4. ASPIRE- GCSC shall select the students and will give admission to the aspirants based on their performance in the written test and viva-voce.

3. Each correct answer will carry 1 mark. There will be negative marking @0.25 marks for each wrong answer. No marks will be awarded or deducted if any question is left un-attempted.

ADMIT CARD

- 1. on submission of the duly filled Application form and submission of application cost at the respective block offices/ municipality the candidate shall be handed over the admit card duly signed by the Block Development officer/ Municipality Executive Officer respectively.
- 2. The candidates will have to produce the hard copy in original of the admit card along with ld proof at the examination centre for appearing in the examination.

GENERAL TERMS AND CONDITIONS:

- 1. Selected students will be provided free non-residential coaching for qualifying Competitive Exams like (OSSC/OSSSC, Railways, Banking, OPRB (Police), OPSC- OCS, UPSC- CSE etc..). Free coaching course may include classes on (a) General Studies (b) Quantitative Aptitude (c) English & Odia Language, (d) General Intelligence & Logical Reasoning.
- 2. The Test Series & Answer evaluation shall be part of the curriculum/course.
- 3. The Scheme is opened for students of Bamanghaty Sub-Division (Blocks- Kusumi, Jamda, Rairangpur, Tiring, Bahalda, Bisoi, Bijatala and Rairangpur Municipality)
- 4. The student enrolled under this scheme shall have to attend all the classes. In case of remaining absent for more than 10 (ten) days without any valid reason, or leaving the coaching midway without prior approval of the competent authority, the total expenditure incurred on the candidate will be recovered from the student concerned.
- 5. The programme is non-residential. Thus, the admitted students have to make necessary arrangement of their food and stay by their own.
- 6. The institute will maintain attendance registers for all students enrolled for the course as well as subject-wise results of practice tests, or any other evaluation.

Terms and Conditions

- 1. The information contained in the Admission Application Form could be changed/ modified from time to time by Competent Authority of ASPIRE-GCSA.
- 2. The ASPIRE-GCSA reserves its right to modify/cancel the admission of successful candidate under any of the following circumstance:
