- The Mission Shakti SHG / Transgenders / Waste Pickers members called as Swachh Karmi (**15 Nos.- 14 Nos. of Swachh Karmi + 01 No. Supervisor with Care Taker cum Watchman**) must have to work at the Wealth Centre for the production of Mo Khata and keep the premises neat and clean.
- The Standard Operating Procedure (SOP) vide letter No.-16040/HUD, dt.26.09.2022 of the H&UD Deptt., Govt. of Odisha will be strictly followed without any deviation.
- All the Swachh Karmi will be paid @ **Rs.14,800/- (Fourteen thousand eight hundred only** per month towards incentive subject to deduction towards absent if any.
- For proper O & M of the wealth center the SHG group will get 5% of supervision charges of their total worker's wages value per month.
- If any of the swachha karmi will be absent from duties the wages amount will deducted from monthly incentives.
- The Mission Shakti SHG / Transgenders / Waste Pickers must belong to the Rairangpur Municipality.
